# A Bylaw to establish a Municipal Ticketing Information System in the Village of Salmo

WHEREAS Section 260 of the Community Charter authorizes the Council to:

- 1. designate those bylaws that may be enforced by means of a ticket prescribed by regulation under the Community Charter,
- 2. designate a prescribed class of persons as bylaw enforcement officers for the purpose of enforcing bylaws by means of the prescribed ticket;
- 3. designate an offence against a bylaw by means of a word or expression on a ticket; and
- 4. set fines, not exceeding two thousand dollars (\$2000.00) dollars, for contravention of the designated bylaws.

THEREFORE the Council of the Village of Salmo in open meeting assembled, enacts as follows:

#### SHORT TITLE

1. This Bylaw may be cited as the "TICKET INFORMATION UTILIZATION BYLAW 2007"

#### **APPLICATION**

- 2. That the Dog Licensing & Control Bylaw 2007 #585 may be enforced by means of a ticket in the form prescribed for this purpose pursuant to s. 264(1) of the *Community Charter*.
- 3. A Bylaw Enforcement Officer pursuant to s. 264(1)(b) of the Community Charter has been designated by Council for the purpose of enforcing the Dog Licensing & Control Bylaw #585
- BL 625 as set forth in Schedule "B" attached to and forming part of this bylaw.
  - 4. The words or expressions set forth in Column 1 of Schedule "A" designate the offence committed under the bylaw section number appearing in column 2 of Schedules "A".

5. The amounts appearing in Column 3 of Schedule "A" are the fines set pursuant to the Community Charter for the corresponding offences designated in Column 1 of Schedule "A" opposite the respective amounts.

#### **ENACTMENT**

- 6. If any section, subsection, sentence, clause or phrase of this Bylaw is for any reason held to be invalid by the decision of any court of competent jurisdiction, the invalid portion(s) shall be severed, and the part(s) that is (are) invalid shall not affect the validity of the remainder of this Bylaw.
- 7. This Bylaw shall come into full force and effect on the final adoption thereof.
