BYLAW NO. 680

A BYLAW TO SET THE PARCEL TAX FOR WATER AND SANITARY SEWER SERVICES ON VILLAGE PROPERTIES

WHEREAS Section 200 of the *Community Charter*, 2003 SBC, c. 26, provides that Council may, by bylaw, impose a parcel tax to provide all or part of the funding for a service;

AND WHEREAS Council considers it desirable to impose a parcel tax for the capital upgrades to the services of the water and sanitary sewer services of the Village of Salmo;

NOW THEREFORE, the Council of the Corporation of the Village of Salmo, in open meeting assembled, ENACTS AS FOLLOWS:

TITLE

1. This Bylaw may be cited as the "WATER AND SEWER SERVICE PARCEL TAX BYLAW NO. 680, 2016".

IMPOSITION OF PARCEL TAX

2. A parcel tax as set out in this Bylaw is imposed on each parcel within the Village of Salmo.

EXEMPT PARCELS

3. Notwithstanding section 2, the parcel tax is not payable in any year in respect of any parcel of land, which is exempt from taxation pursuant to the provisions of the *Community Charter*, or pursuant to a tax exemption bylaw adopted by the Council under the *Community Charter*.

PURPOSE OF TAX

4. The parcel tax imposed under section 2 of this Bylaw is for the purpose of raising money for the costs of the water and sanitary sewer service of the Village of Salmo.

YEARS OF APPLICATION

5. The parcel tax imposed under Section 2 of this Bylaw shall be imposed in 2016 and shall remain in effect for 1 year.

PARCEL TAX BASIS

6. The water parcel tax imposed under section 2 of this Bylaw shall be on the basis on a single amount for each parcel in the amount of \$130.72 per annum.
7. The sanitary sewer parcel tax imposed under section 2 of this Bylaw shall be on the basis on a single amount for each parcel in the amount of \$32.57 per annum.

PARCEL TAX ROLL

8. The authenticated parcel tax roll prepared pursuant to the Water and Sanitary Sewer Parcel Tax Roll Bylaw, must be used to impose the parcel tax.

READ A THIRD TIME this 5th day of May, 2016
