

THE CORPORATION OF THE VILLAGE OF SALMO

BY-LAW NO. 340

Being a by-law to authorize an exchange of lands pursuant to Section 574 of the Municipal Act.

WHEREAS it is deemed desirable and expedient to close certain portions of road described as parts of road and lane adjacent to Lot 8, Block B, Plan 2710, District Lots 206 and 206A, Kootenay District in exchange for parts of Lots 1, 2, 3, remainder of Lots 4 and 8, all of Block B, Plan 2710, District Lots 206 and 206A, Kootenay District for the purpose of improving and widening the road.

AND WHEREAS the provisions of Section 574(3) of the Municipal Act have been met and notice of intention of the exchange has been published once each week for two consecutive weeks in the Nelson Daily News;

NOW THEREFORE the Council of the Corporation of the Village of Salmo in open meeting assembled, enacts as follows:

1. Those parts of road and lane adjacent to Lot 8, Block B, Plan 2710, District Lots 206 and 206A, Kootenay District, as shown outlined in bold on explanatory plan hereto attached and prepared by Raymond Johnson, B.C.L.S. and dated June 8, 1989 are hereby stopped and closed up to traffic of all kinds and conveyed to Merle O. Hanson and Corinne L. Hanson.
2. In consideration therefore, Merle O. Hanson and Corinne L. Hanson shall convey to the Corporation of the Village of Salmo parts of Lots 1, 2, 3, remainder of Lots 4 and 8, all of Block B, Plan 2710, District Lots 206 and 206A, Kootenay District as shown outlined in bold on explanatory plan hereto attached and prepared by Raymond Johnson, B.C.L.S. and dated June 8, 1989 for the purpose of being dedicated a public road pursuant to the provisions of Section 578 of the Municipal Act.
3. The Deputy-Mayor and the Clerk-Treasurer be and are hereby authorized and empowered to execute such documents as may be necessary to expedite the land exchange.

4. This by-law may be cited for all purposes as the "Village of Salmo Land Exchange By-law No. 340, 1989".

5. This by-law shall come into force and take effect upon registration with the Inspector of Municipalities.


