A BYLAW FOR THE APPOINTMENT AND REMUNERATION FOR ELECTION OFFICIALS FOR MUNICIPAL ELECTION IN THE VILLAGE OF SALMO

WHEREAS Part 3 of the *Local Government Act* requires Council to determine procedures and requirements to be applied to the conduct of local government elections and other voting, and

WHEREAS Council must appoint municipal election officials, and

WHEREAS Council wishes to establish remuneration rates for municipal election officials,

NOW THEREFORE, the Council of the Village of Salmo, in open meeting assembled, hereby ENACTS AS FOLLOWS:

1. CITATION

- 1.1. This by-law shall be known and cited for all purposes as the Village of Salmo "ELECTION OFFICIALS BYLAW".

2. ELECTION OFFICIALS

- 2.1. Council shall appoint a Chief Election Officer and a Deputy Chief Election Officer.
- 2.2. The Chief Election Officer must appoint election officials required for the administration and conduct of the election as deemed necessary for the election.
- 2.3. The Chief Election Officer may appoint election officials as deemed necessary for the election.

3. DUTIES

- 3.1. All appointed election officials shall perform their appointed duties as stated in the *Local Government Act*.

4. REMUNERATION

- 4.1. Election officials shall be remunerated as follows:
 - (a) Chief Election Officer - \$950.00 (BL742)
 - (b) Deputy Chief Election Officer - \$850.00 (BL742)
 - (c) Election Officials - \$700.00 (BL742)
- 4.2. The rates established in this section shall be deemed to be payment for all services provided by election officials in the course of a municipal election.

5. MEALS

- 5.1. Meals are to be provided for all appointed election officials during advanced voting opportunities and general voting day. (BL742)

6. ENACTMENT

- 6.1. If any section, subsection, sentence, clause, or phrase of this Bylaw is for any reason held to be invalid by the decision of any court of competent jurisdiction, the invalid portion shall be severed and the part that is invalid shall not affect the validity of the remainder.
- 6.2. This Bylaw shall come into full force on the final adoption thereof.
