

**THE CORPORATION OF THE VILLAGE OF SALMO**

**BYLAW #744**

A BYLAW TO SET THE MEANS OF PUBLISHING A NOTICE IN ACCORDANCE WITH SECTION 94.2 OF THE  
*COMMUNITY CHARTER*

---

WHEREAS Division 4 of Part 3 of the *Community Charter* authorizes Council to adopt a bylaw providing for alternative means of publishing a notice instead of publishing the notice in a newspaper once each week for two consecutive weeks;

AND WHEREAS such a bylaw is required to specify at least two means of publication by which a notice is to be published, not including posting in the public notice posting places;

AND WHEREAS Council has considered the principles of reliability, suitability and accessibility as they apply to the means of publishing a public notice;

NOW, THEREFORE the Council of the Village of Salmo in open meeting assembled, ENACTS AS FOLLOWS:

**1. CITATION**

This Bylaw may be cited as the Village of Salmo "**PUBLIC NOTICE BYLAW #744, 2022**".

**2. DEFINITIONS**

"Village Facebook" means the official Facebook page of the Village of Salmo  
(<https://www.facebook.com/VillageofSalmo>);

"Village Website" means the official website of the Village of Salmo ([www.salmo.ca](http://www.salmo.ca)).

**3. NOTICE TO THE PUBLIC**

- (a) Where the Village of Salmo is required under Section 94 of the *Community Charter* to give notice to the public, the notice shall be given in a form and manner indicated in this bylaw.
- (b) Any required notice shall be:
  - i. posted on the Village Facebook page; and
  - ii. posted on the Village website.
- (c) The content of any required notice shall be as prescribed in the *Community Charter* or *Local Government Act*.
- (d) The date and time where any required notice shall be posted shall be as prescribed in the *Community Charter* or *Local Government Act*.

**4. ADDITIONAL NOTICES**

The notice requirements set forth in this Bylaw are minimum requirements and are not intended to limit Council’s discretion to direct staff to provide additional notices, utilizing different or additional methods or repeating notice, as may be deemed appropriate by Council.

**5. EFFECTIVE DATE**

This Bylaw shall come into full force and effect on adoption.
