**QUALIFICATIONS FOR OFFICE**

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- a Canadian citizen;
- 18 years of age or older on general voting day (Saturday, February 25, 2023)
- a resident of British Columbia for at least 6 months immediately before the day nomination papers are filed; and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election in British Columbia or being nominated for, being elected to or holding the office, or be otherwise disqualified by law

**CAMPAIGN PERIOD EXPENSE LIMITS**

In accordance with the *Local Elections Campaign Financing Act*, for the 2023 local by-election, the following expense limits for candidates during the campaign period apply:

Mayor	\$10,797.83
Councillor	\$5,398.92

**THIRD PARTY ADVERTISING LIMITS**

In accordance with the *Local Elections Campaign Financing Act*, for the 2023 local by-elections, the following third-party advertising limits apply:
