## **KP PARK CAMPGROUND BYLAW**

WHEREAS pursuant to the *Community Charter*, Council may, by bylaw, regulate, prohibit and impose requirements in relation to the management of services and use of Parks and Public Spaces within the Village of Salmo and under the jurisdiction of the Village of Salmo, held by the said Village for pleasure, recreation, or community uses of the public. KP Park Campground is a municipal campground in a recreational park providing temporary camping sites for transient visitors.

The Municipal Council of the Corporation of the Village of Salmo, in open meeting assembled, enacts the following:

#### 1. CITATION

1.1. This bylaw may be sited as the "KP Park Campground User Bylaw #709, 2019".

#### 2. USER FEES

- 2.1. Subject to sub-section 2.2, a user fee in the amount of \$20.00 per night and per sleeping unit (e.g. tent, trailer, motor-home/recreational vehicle [RV]) shall be payable for the use of the campground for overnight accommodation. (BL748)
- 2.2. Notwithstanding sub-section 2.1, a tent set up in conjunction with a primary sleeping unit in the campground for occupancy by youth under the age of seventeen (17) years and in the care of the occupants of the primary sleeping unit for which a user fee has been paid, shall be exempt from the fee imposed by this section.
- 2.3. All fees are due and payable on arrival to the Campground Manager, in advance of stay.
- 2.4. The use of and access to water provided at the campground shall be a service included in the user fee paid pursuant to this Bylaw.
- 2.5. The use of the campground showers is <u>not</u> included in the user fee.
- 2.6. KP Park Campground is <u>not</u> a participant in the Provincial Park program that provides free camping for registered campers with disabilities.

#### 3. USE OF CAMPSITES

3.1. The maximum length of stay in any six month period for any tent, tent-trailer or motorhome/recreational vehicle (RV) in the campground is 14 nights (two weeks).

- 3.2. Campsites are available on a first-come, first-served basis.
- 3.3. On request, a specific number of sites may be reserved in advance for a special event such as a family reunion or baseball tournament. Requests must:
  - (a) Be received in writing a minimum of 30 business days prior to the event and are subject to the availability of the park facilities.
  - (b) Be reviewed and approved by the Chief Administrative Officer.
  - (c) No reservations will be taken for the Canada Day weekend.
- 3.4. Campers must be respectful of other campers and nearby residents and abide by the Village's Noise Control Bylaw. Campers who fail to comply will be asked to leave the campground immediately and may be removed from the campground by police escort, if necessary.

#### 4. USE OF GENERATORS

4.1. Internal combustion engine generator use is only permitted between the hours of 9:00 am - 11:00 am and from 6:00 pm - 8:00 pm.

#### 5. CAMPFIRES & SMOKING

- 5.1. Campfires and Smoking are subject to the regulations laid out in the Parks & Publicly-Owned Spaces Regulations Bylaw.
- 5.2. No campfires are allowed during a fire ban period.

#### 6. REPEAL

6.1. Bylaw #525 is hereby repealed and replaced.

#### 7. ENACTMENT

- 7.1. If any section, subsection, sentence, clause or phrase of this Bylaw is for any reason held to be invalid by the decision of any court of competent jurisdiction, the invalid portion shall be severed and the part that is invalid shall not affect the validity of the remainder.
- 7.2. This bylaw amendment shall come into full force and effect on final adoption.
